Welcome to Scholarships 4 Us® **Inaugural 23-Week Program**. Students in the Class of **2024** will have the opportunity to be the first to experience The Scholarships 4 Us Program which will soon be available to every student in America from 6th – 12th grade.

How The Scholarships 4 Us Program Works

According to IRS Topic No. 421; a scholarship is non-taxable so long the amount received is used for enrollment at an educational institution or necessary supplies for a course at an educational institution. The amount of accumulated prize funds you earn through the series of Accredited Events will be disbursed directly to your educational institution as a Scholarship Award. The objective of the Inaugural 23-Week Program is to establish the business workflow and provide high school seniors the opportunity to earn scholarship funds before leaving for school.

When a student enrolls they will establish an **ESA (Earning and Savings Account)** that is assigned to an **Enrollment ID** that will permit them to purchase tickets to our upcoming events once they submit their Activation Requirements on the Scholarships 4 Us website. This will allow us to keep track record of accrued savings, accumulated prize funds, and event participation history which is managed within the Members' Account on the Scholarships 4 Us website. Enrollees will be provided their own profile at www.Scholarships4Us.com/ESA.

Scholarships 4 Us® is the Legislative-Compliance enterprise for potential collegiate athletes and students. The Scholarships 4 Us® Program maintains Amateurism compliance by ensuring prize funds are disbursed as a Scholarship Award. 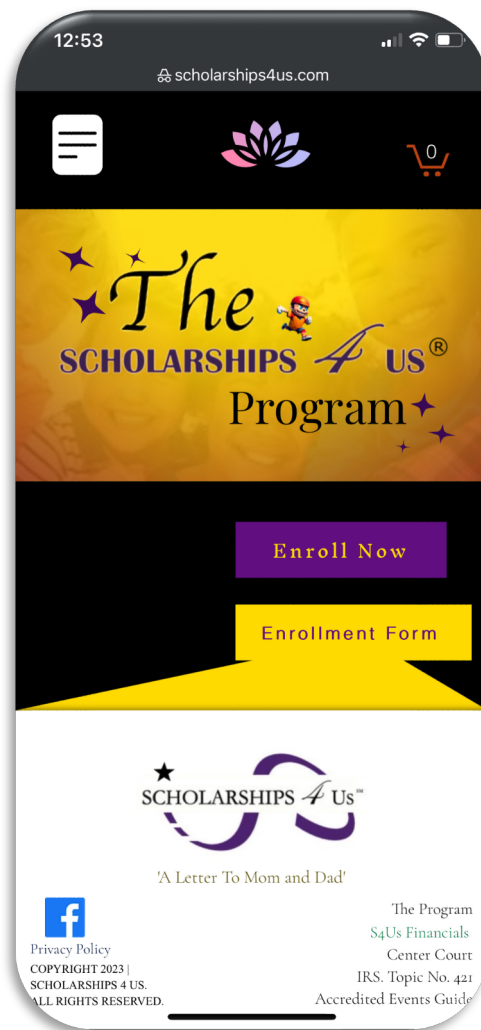
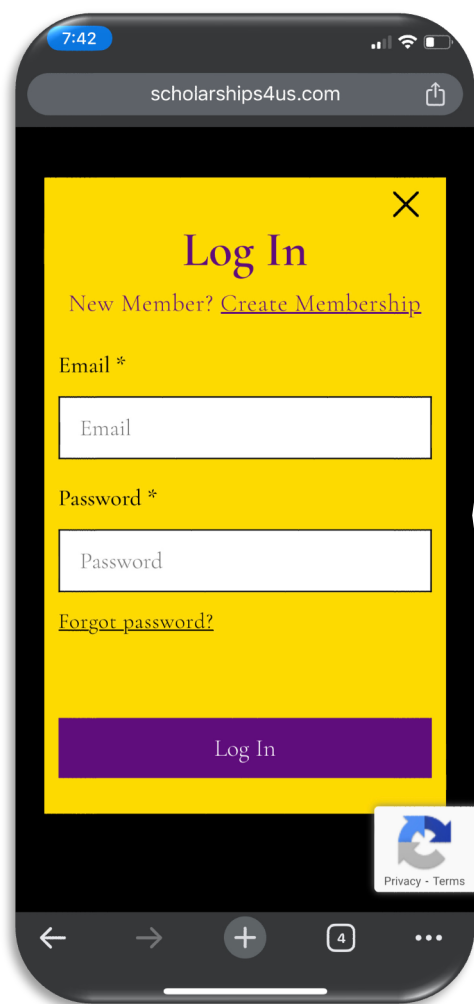
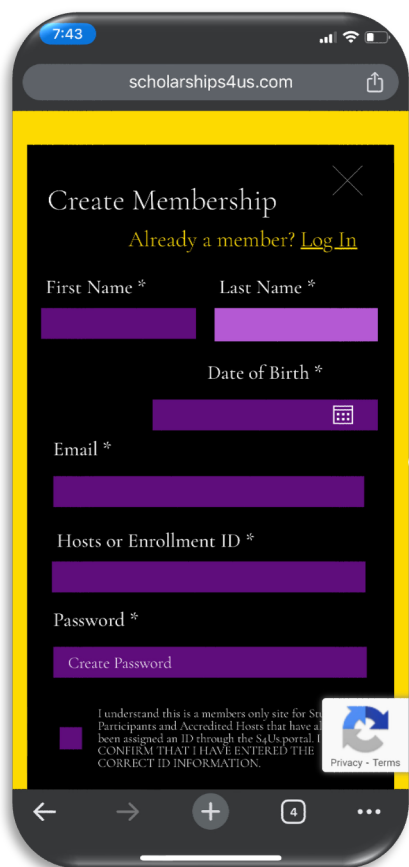


Students must meet the following eligibility criterion in order to participate in the Inaugural 23-Week Program:

- ✚ Actively enrolled in a U.S. Charter, Home, Public or Private Educational Institution*
- ✚ Be of age within the Eligibility Time Period
 - A students Eligibility Time Period begins the day of a students' 12th Birthday and expires May 31st their senior year of high school.
- ✚ Graduating in 2024
- ✚ If under 18, the student must have a Parent, Legal Guardian, or Authorized Representative present at the time of enrollment to sign and agree to the 'Parent, Legal Guardian or Authorized Representative Rights and Responsibilities' form and ensure that the potential Student-Participant has consent to sign the 'Student-Participant Rights and Responsibilities' form
- ✚ Sign and agree to the 'Student-Participant Rights and Responsibilities'

*International Exchange or Study Aboard Students are not eligible to enroll in The Program

- Complete the form and submit the photo you want for the website to Enrollment@Scholarships4Us.com in .PDF form. Use the Subject Line- 'Enrollment: (Last Name, First Name (DOB)).'
- Once eligibility is determined then an email will be sent with your **Enrollment ID** and a link to submit your Activation Requirements at www.Scholarships4Us.com/Membership. Once submitted, you will have established your ESA (Earning and Savings Account) www.Scholarships4Us.com/ESA that provides you an active track record of your accumulated Prize Funds and Savings Contributions. You will also be required to enter your Enrollment ID at checkout when purchasing tickets to events. At the end of each event you will provide your Enrollment ID to the Accredited Hosts.

2. All ticket sales are **FINAL** and **NON-REFUNDABLE**
3. Each ticket must be purchased individually using the Student-Participants name, email, and Enrollment ID
4. Only **1-ticket** purchase is permissible **per** participant **per** event
5. Taxation will be **PAID BY THE BUYER** according to national, state and/or local applicable laws
6. A Wix Service Fee applies at **2.5%** and is **PASSED ON TO THE BUYER**
7. Tickets will be emailed and the QR Code can be scanned at check-in
8. A Student-Participant that is unable to attend the event will **FORFEIT** their prize fund, expense and lineage but will be **CREDITED** their Savings Contribution.

- ◆ Processing of disbursements is scheduled from **July 1st – July 31st**
- ◆ All disbursements* are mailed out annually on **August 1st** in two separate checks

3. Prize Money

- c. DISBURSEMENT IS MAILED DIRECTLY TO THE FORMER STUDENT-PARTICIPANT
