"Scholarships 4 Us, LLC is the Legislative-Compliance enterprise for high school students and potential collegiate athletes to ensure their eligibility is maintained to compete in their prospective league or association through the prudent and secure management of Prize Money in The Trust of Scholarships 4 Us. We provide students a national standardized platform to accumulate Prize Funds funded with Prize Money in competitions and tournaments and Exclusive Rights of Use for the S4Us.portal™ and The Trust of Scholarships 4 Us for youth organizations to manage the events.

When an eligible student enrolls in The Scholarships 4 Us Program the student establishes what is known as their (ESA) Earning and Savings Account that is assigned to an Enrollment ID. In every event, Student-Participants will accrue savings and have the opportunity to accumulate Prize Funds funded with Prize Money based on Place Finish. The accrued savings and Prize Funds funded with Prize Money shall be managed within The Trust of Scholarships 4 Us which is managed using the S4Us.portal™.

Scholarships 4 Us, LLC is *not* a nonprofit scholarship organization that manages and disburses donor and sponsor tax-deductible contributions. We are a for-profit third-party enterprise that manages Prize Funds funded with Prize Money under The 5 Principles of Amateurism with the intended purpose for the funds to be disbursed as a Scholarship Award. Former Student-Participants are entitled to request their accumulated Prize Funds funded with Prize Money as either Prize Money (taxable income) or a Scholarship Award (non-taxable income).

Usage of The Scholarships 4 Us Program ensures high school students and potential collegiate athletes maintain their eligibility to compete in their prospective league or association through the prudent and secure management of Prize Money in The Trust of Scholarships 4 Us. Scholarships 4 Us, LLC has no affiliation with the NCAA®, NAIA®, NJCAA®, NACE®, or postsecondary educational institutions but may provide records regarding Student-Participants' enrollment, participation, and disbursement request to ensure our commitment to being the Legislative-Compliance enterprise for high school students and potential collegiate athletes."

THE NJCAA® BYLAWS STATE THAT NO POTENTIAL STUDENT-ATHLETE CAN ACCEPT PRIZE MONEY AFTER THEIR 19TH BIRTHDAY OR ENROLLED IN A NJCAA® INSTITUTION- WHICHEVER ONE COMES FIRST.

THE IRS MUST PROVIDE 'GRANT APPROVAL FOR GRANT-MAKING PROCEDURES' AS A 'PRIVATE FOUNDATION' TO GIVE THE ORGANIZATION LEGAL RIGHT TO BE RECOGNIZED AS A SCHOLARSHIP PROVIDER

YOUTH ORGANIZATIONS

ACADEMIES, CAMPS, CLINICS, CLUBS, EVENT MANAGERS, PROGRAMS, TOURNAMENT DIRECTORS, SCHOOLS AND VENUE OWNERS THAT SPECIALIZE IN THE ARTS, ESPORTS OR SPORTS

Scholarships 4 Us, LLC was founded to fund The Scholarship System 4 Us through youth organizations that specialize in The Arts, Sports, or Esports, registering as an Accredited Hosts™ and managing Accredited Events.

- ◆ An **Accredited Event™** is a competition or tournament that awards **Prize Funds** funded with **Prize Money** based on Place Finish.
- ◆ The **Cost of Entry** in an Accredited Event™ is either **\$40**, **\$80**, or **\$160** and is itemized as followed:
 - **25%: Savings Contribution**
 - **25%: Expense and Lineage**
 - Expense is the fee charge for Accredited Hosts™
 - Lineage is the fee charge for Scholarships 4 Us, LLC
 - **50%: Prize Fund**
- ◆ An Accredited Event™ will be described on the Scholarships 4 Us, LLC website under the Events Page and corresponding subcategory: **The Arts**, **Sports**, or **Esports**.
- ◆ An **Accredited Hosts™** will be assigned to a **Hosts ID** through the **S4Us.portal™** to create an Accredited Event™ registration form for student-participants to register.
- ◆ Eligible students will enroll in **The Scholarships 4 Us Program** through the S4Us.portal™ and be provided an **(ESA) Earnings and Savings Account** assigned to an **Enrollment ID**. The Enrollment ID is used to register for an Accredited Event™ and keep track record of their participation and ESA.
- ◆ An enrolled student will be recognized as a **Student-Participant** that competes in an Accredited Event™ and will **accrue savings** in every event they participate in and have the opportunity to accumulate Prize Funds funded with Prize Money based on Place Finish.

- ◆ The Accredited Hosts™ and Student-Participants will use the **Scholarships 4 Us, LLC Accredited Events Guide** to determine the Cost of Entry in an Accredited Event™ which determines the **Allocation of Itemized Prize Funds**.
- ◆ Accredited Hosts™ will collect their **Lineage Fee** at the Accredited Event™ while the **Savings Contribution, Expense, and Prize Fund** will be submitted to Scholarships 4 Us, LLC through the S4Us.portal™ at registration.
- ◆ After completion of the Accredited Event™ the Accredited Hosts™ will submit the **Close An Event Form** with Place Finish using the Student-Participants' Enrollment ID through the S4Us.portal™.
- ◆ Prize Funds and Savings Contributions will be managed in **The Trust of Scholarships 4 Us**.
- ◆ **The Trust of Scholarships 4 Us Service Agreement** shall be signed by all Student-Participants and Accredited Hosts™ at the time of enrollment or registration.
- ◆ A Student-Participant is entitled to directly receive their accrued Savings Contributions which must be requested through the S4Us.portal™.
- ◆ A Student-Participant is entitled to receive their accumulate Prize Money as either a Scholarship Award (non-taxable income) or Prize Money (taxable-income) which must be requested through the S4Us.portal™. If a prospective league or association will determine a former Student-Participant of The Scholarships 4 Us Program ineligible for accepting Prize Money based on Place Finish, Scholarships 4 Us, LLC will disburse the Prize Fund funded with Prize Money directly to the educational institution as a Scholarship Award.

No longer will every student in America have a 97% chance of NOT being selected as a recipient of the 1.7 million scholarships awarded each year or a 98% chance of NOT being offered an Athletic Scholarship. A Scholarship, since the first one was awarded almost 400 years ago, was never an actual '*thing*,' it is 'non-taxable income.' America will become united in The Scholarship System 4 Us by ensuring that all students are enrolled in The Scholarships 4 Us® Program for as long as it is useful for our kind.

The high school leagues and collegiate athletic associations create legislation for participation in their competitions or tournaments which includes accepting Prize Money based on Place Finish. Scholarships 4 Us, LLC ensures students maintain eligibility for their prospective league or association through the prudent and secure management of Prize Money in The Trust of Scholarships 4 Us. Below are the organizations with jurisdiction to define what a Scholarship 'is' and to determine a student ineligible to compete in their competitions or tournaments as it relates to Scholarships 4 Us, LLC.

IRS

The IRS topic no. 421 scholarships, fellowship grants, and other grants recognizes these award earnings as tax-free so as long the "amount is used to pay for tuition and fees required for enrollment or attendance at the educational institution, or for fees, books, supplies, and equipment required for courses at the educational institution." Any other usage of the awards for "incidental expenses, such as room and board, travel or optional equipment must be reported as gross income.

NFHS

The NFHS writes the playing guidelines for its member state associations or leagues which includes the jurisdiction to determine high school students and potential collegiate athletes ineligible to compete in their competitions and tournaments if they accept Prize Money based on Place Finish. However, each state association or league has autonomy to implement their own governing principles to determine eligibility requirements.

NCAA®

The NCAA® permits potential collegiate students-athletes to earn prize money based on place finish in events so long as the amount does not exceed actual and necessary expenses to participate. The NCAA® requires all potential collegiate student-athletes to complete their Eligibility Questionnaire to determine if amateurism status has been maintained by requesting documentation of sports participation and any accepted prize money. These records are to be kept by the student-athlete and any misinformation or falsification could lead to a determination resulting in a permanent ineligibility status.

NAIA®

Potential collegiate student-athletes must complete their Eligibility Questionnaire and the bylaws state that no potential collegiate student-athlete can accept prize money after July 31st, the 'last day of summer,' prior to enrolling into an NAIA® institution. These records are to be kept by the student-athlete and any misinformation or falsification could lead to a determination resulting in a permanent ineligibility status.

NJCAA®

Potential collegiate student-athletes must complete their Amateurism Questionnaire and the bylaws state that no potential collegiate student-athlete can accept prize money after their 19th birthday or once enrolled in an NJCAA® institution- whichever comes first. These records are to be kept by the student-athlete and any misinformation or falsification could lead to a determination resulting in a permanent ineligibility status.

NACE®

Potential collegiate student-athletes must complete their Eligibility Certificate Form, and the bylaws do not state legislation governing student-athletes accepting prize money.

POST-SECONDARY EDUCATION INSTITUTIONS

Postsecondary educational institutions require all students to report private awarded scholarships to the Financial Aid Department as it may adjust their Financial Aid Award.

Scholarships 4 Us, LLC requires youth organizations to register as an Accredited Hosts™ for Exclusive Rights of Use for the S4Us.portal™ and The Trust of Scholarships 4 Us. The Registration Requirements and procedure is written to ensure high school students and potential collegiate athletes have trusted managing entities for Accredited Events.

- A clear and precise mission that directly correlates with The Scholarships 4 Us Program's mission and purpose
- Provide Articles of Organization/Corporation and proof of General Liability Insurance*
- Sign and agree to the Terms and Conditions of Use

The following Terms and Conditions of Use are the governing principles set forth by Scholarships 4 Us, LLC to ensure Accredited Hosts™ protect the integrity of The Scholarships 4 Us Program.

Condition Statement

Youth Organizations are required to provide Articles of Incorporation/Organization, and General Liability Insurance at the time of registration. 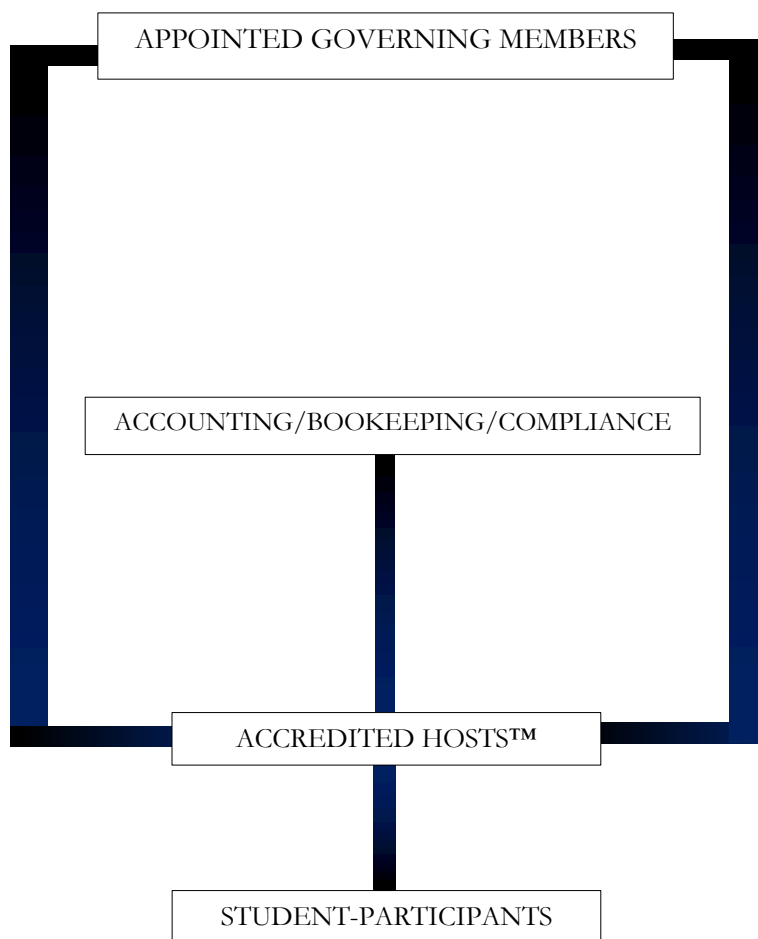
