

"Scholarships 4 Us<sup>®</sup> is the Legislative-Compliance enterprise for potential collegiate athletes and students. We provide students a national standardized platform to accumulate Prize Money in our Accredited Events and Exclusive Rights of Use for youth organizations to manage the events. When an eligible student enrolls the person becomes a participant in The Scholarships 4 Us<sup>®</sup> Program and establishes what is known as their ESA or Earning and Savings Account that is assigned to an Enrollment ID. In every event, Student-Participants will accrue savings and have the opportunity to accumulate Prize Funds funded with Prize Money based on Place Finish. The Prize Funds funded with Prize Money shall be managed within The Trust of Scholarships 4 Us<sup>®</sup> which is maintained using the S4Us.portal<sup>™</sup>.

THE PROGRAM

SCHOLARSHIPS 4 Us®

Scholarships 4 Us<sup>®</sup> is *not* a nonprofit scholarship that manages and disburses donor and sponsor contributions. We are a for profit third-party enterprise that manages Prize Funds funded with Prize Money under Scholarships 4 Us: The Rule of Amateurism<sup>™</sup> with the intended purpose for the funds to be disbursed as a Scholarship Award. Former Student-Participants are entitled to request their accumulated Prize Funds funded with Prize Money as either Prize Money (taxable income) or a Scholarship Award (non-taxable income).

Usage of The Scholarships 4 Us<sup>®</sup> Program protects potential collegiate athletes' eligibility standards set forth by the NCAA<sup>®</sup>, NAIA<sup>®</sup>, NJCAA<sup>®</sup>, and NACE<sup>®</sup>. Scholarships 4 Us<sup>®</sup> has no affiliation with the NCAA<sup>®</sup>, NAIA<sup>®</sup>, NJCAA<sup>®</sup>, NACE<sup>®</sup>, or postsecondary educational institutions but may provide records regarding Student-Participants' enrollment, participation, and disbursement request to ensure our commitment to being the Legislative-Compliance enterprise for potential collegiate athletes and students."

THE NAIA® BYLAWS STATE THAT NO POTENTIAL COLLEGIATE STUDENT-ATHLETE CAN ACCEPT PRIZE MONEY AFTER JULY 1<sup>ST</sup>, THE 'LAST DAY OF SUMMER,' PRIOR TO ENROLLING INTO AN NAIA® INSTITUTION. THE NJCAA® BYLAWS STATE THAT NO POTENTIAL STUDENT-ATHLETE CAN ACCEPT PRIZE MONEY AFTER THEIR 19<sup>TH</sup> BIRTHDAY OR ENROLLED IN A NJCAA® INSTITUTION- WHICHEVER ONE COMES FIRST.

THE IRS MUST PROVIDE 'GRANT APPROVAL FOR GRANT-MAKING PROCEDURES' AS A 'PRIVATE FOUNDATION' TO GIVE THE ORGANIZATION LEGAL RIGHT TO BE RECOGNIZED AS A SCHOLARSHIP PROVIDER

Scholarships 4 Us<sup>®</sup> was founded to fund The Scholarship System 4 Us through secondary educational institutions and youth organizations that specialize in The Arts, Sports, or Esports, registering as an Accredited Hosts<sup>™</sup> and managing Accredited Events.

- o The Cost of Entry in an Accredited Event<sup>™</sup> is either \$40, \$80, or \$160
- The Cost of Entry is itemized as followed:
  - -25%: Savings Contribution
  - -25%: Event Cost (Expense and Lineage)\*
    - \*The Expense is the Fee for Scholarships 4 Us® and the Lineage is the fee for the Accredited Hosts
  - -50%: Prize Fund
- o An Accredited Event<sup>™</sup> will use the Allocation of Itemized Prize Funds found in The Scholarships 4 Us<sup>®</sup> Accredited Events Guide
- o Prize Funds and Savings Contributions will be managed in Trust of Scholarships 4 Us®
- o The Trust of Scholarships 4 Us<sup>®</sup> Service Agreement shall be signed by all Student-Participants and Accredited Hosts™.
- o An Accredited Hosts<sup>™</sup> may request to use the trust as a service to manage their own Accredited Events.
- A student is eligible to enroll in The Scholarships 4 Us<sup>®</sup> Program on their 12<sup>th</sup> birthday with an Expiration of Eligibility on May 31<sup>st</sup> their senior year of high school.
- Each student that enrolls in The Scholarships 4 Us<sup>®</sup> Program will be provided an ESA (Earning and Savings Account) assigned to an Enrollment ID in the S4Us.portal<sup>™</sup>.
- Student-Participants will accrue savings in every event they participate in and have the opportunity to accumulate Prize Funds funded with Prize Money based on Place Finish.

• Savings Contributions and Prize Funds will be managed in The Trust of Scholarships 4 Us<sup>®</sup>.







- Scholarships 4 Us<sup>®</sup> shall recognize The Rule of Amateurism<sup>™</sup> as our Purpose of Formation. A Student-Participant may forfeit their accumulated Prize Funds if it determined that they have intentionally failed to disclose they withdrew from The Rule of Amateurism.
- Third-party funding to increase the Prize Funds and Savings Contributions are forbidden in an Accredited Event<sup>™</sup> and an Accredited Hosts<sup>™</sup> determined to have initiated or was aware and failed to prevent such transaction will have a revocation of their accreditation.
- The Scholarships 4 Us<sup>®</sup> Program is designed for primary educational institutions to receive a percentage of the Lineage revenue earned by secondary educational institutions within their district, tax-free, so long as the funds are used according to IRS Topic No. 421.
- Scholarships 4 Us<sup>®</sup> may also determine a limited number of neutral organizations, and a system of allocation, where individuals and businesses can contribute funding directly for Student-Participants' Cost of Entry in an Accredited Event™.

No longer will every student in America have a 97% chance of NOT being selected as a recipient of the 1.7 million scholarships awarded each year or a 98% chance of NOT being offered an Athletic Scholarship. A Scholarship, since the first one was awarded almost 400 years ago, was never an actual '*thing*,' it is 'non-taxable income.' America will become united in The Scholarship System 4 Us by ensuring that all students are enrolled in The Scholarships 4 Us<sup>®</sup> Program for as long as The Program<sup>™</sup> is useful for our kind.





THE PROGRAM

The Scholarships 4 Us<sup>®</sup> Program is formed to be compliant with the legislation of the collegiate athletic associations and the jurisdiction of the IRS. Scholarships 4 Us<sup>®</sup> annually reviews and updates The Scholarships 4 Us<sup>®</sup> Program according to any changes regarding disbursing Prize Money as a Scholarship Award.

# IRS

SCHOLARSHIPS  $\mathcal{A}$  Us<sup>®</sup>

The IRS topic no. 421 scholarships, fellowship grants, and other grants recognizes these award earnings as tax-free so as long the "amount is used to pay for tuition and fees required for enrollment or attendance at the educational institution, or for fees, books, supplies, and equipment required for courses at the educational institution." Any other usage of the awards for "incidental expenses, such as room and board, travel or optional equipment must be reported as gross income.

# <u>NCAA</u>®

The NCAA® permits potential collegiate students-athletes to earn prize money based on place finish in events so long as the amount does not exceed actual and necessary expenses to participate. The NCAA® requires all potential collegiate student-athletes to complete their Eligibility Questionnaire to determine if amateurism status has been maintained by requesting documentation of sports participation and any accepted prize money. These records are to be kept by the student-athlete and any misinformation or falsification could lead to a determination resulting in a permanent ineligibility status.

# <u>NAIA</u>®

Potential collegiate student-athletes must complete their Eligibility Questionnaire and the bylaws state that no potential collegiate student-athlete can accept prize money after July 31st, the 'last day of summer,' prior to enrolling into an NAIA® institution. These records are to be kept by the student-athlete and any misinformation or falsification could lead to a determination resulting in a permanent ineligibility status.

# <u>NJCAA</u>®

Potential collegiate student-athletes must complete their Amateurism Questionnaire and the bylaws state that no potential collegiate student-athlete can accept prize money after their 19<sup>th</sup> birthday or once enrolled in an NJCAA<sup>®</sup> institution- whichever comes first. These records are to be kept by the student-athlete and any misinformation or falsification could lead to a determination resulting in a permanent ineligibility status.

# <u>NACE</u>®

Potential collegiate student-athletes must complete their Eligibility Certificate Form, and the bylaws do not state legislation governing studentathletes accepting prize money.

# POST-SECONDARY EDUCATION INSTITUTIONS

Postsecondary educational institutions require all students to report private awarded scholarships to the Financial Aid Department as it may adjust their Financial Aid Award.







Scholarships 4 Us® requires youth organizations to register as an Accredited Hosts™ for Exclusive Rights to use The Scholarships 4 Us® Program and platforms. The Registration Requirements and procedure is designed to ensure current and future Students-Participants will have a trusted source committed to providing Accredited Events.

The following Terms and Conditions of Use are the governing principles set forth by Scholarships 4 Us<sup>®</sup> to ensure Accredited Hosts<sup>™</sup> protect the integrity of The Scholarships 4 Us<sup>®</sup> Program.

# **Condition Statement**

Youth Organizations are required to provide Articles of Incorporation/Organization and General Liability Insurance at the time of registration. Scholarships 4 Us<sup>®</sup> is not liable for sustained injuries to participants or attendees of Accredited Events and any misconduct or negligence by the business or venue owner(s) and personnel associated 'with' or 'within' the organization(s).

# <u>Terms</u>

- 1. The top priority is to protect the health, safety and well-being of all Student-Participants, families, friends, and spectators
- 2. Scholarships 4 Us<sup>®</sup> has Zero Tolerance for sexual and other abuse or willful misconduct that jeopardizes the health, safety and well-being of Student-Participants, families, friends, or spectators
- 3. Any willful action, publicly or privately, that constitutes bigotry, discrimination, hate, physical violence, politicization, or any other action determined by the ownership company determinantal to The Scholarships 4 Us<sup>®</sup> Program shall be subject to Revocation of Accreditation
- 4. Student-Participants privacy in relation to The Scholarships 4 Us® Program is to remain confidential unless otherwise expressed by a Parent, Legal Guardian, or Authorized Representative
- 5. All Accredited Event<sup>™</sup> funds must be submitted using the S4Us.portal<sup>™</sup> except for the Lineage Fee
- 6. Purchase the Accredited Hosts<sup>™</sup> Start-up Bundle at the time of registration. The Scholarships 4 Us<sup>®</sup> Pennant Banner must be on display at all times in a conspicuous location. The Scholarships 4 Us<sup>®</sup> Table Cover and Scholarships 4 Us<sup>®</sup> Retractable Banner must be used during an Accredited Event<sup>™</sup>. Damage to any item will require purchase of replacement.

# SECTION 9: THE RULE OF AMATEURISM™





Amateurism has been a concept that is misunderstood and misinterpreted and therefore caused more harm than good. In the near future, Scholarships 4 Us® may have absolute jurisdiction over Amateurism when The Scholarships 4 Us® Program is recognized by the postsecondary educational institutions as the Legislative-Compliance enterprise for potential collegiate athletes and students. Every postsecondary educational institution that has a legally binding contract with a collegiate athletic association will have to collectively unite in adopting The Rule of Amateurism<sup>™</sup> for the liberation of the Student-Athlete from authoritarianism.

Furthermore, collegiate Student-Athletes will have to unite in the understanding that they can no longer wait for their 'Financial Share' of the revenue for being a billion dollar asset to postsecondary educational institutions and the collegiate athletic associations. The 'value' of the Cost of Education and the 'value' of Room and Board that has been justified as a 'Fair Share,' in-exchange for services, by the collegiate athletic associations has, since its inception, been breadcrumbs resulting in collegiate athletes being treated like a night walker that has been groomed to be grateful they have a place to sleep and food to eat while their owner relishes in the financial profits from their labor.

The comprehensive approach to forming a national understanding and enforceable practice of Amateurism is through Scholarships 4 Us®: The Rule of Amateurism<sup>™</sup>. Eligibility shall begin on a students' 12th birthday and expire May 31st their senior year of high school. The idea is that once a student graduates high school they will have fulfilled their Amateurism and will then have the choice to request their Accumulated Prize Funds as Prize Money without affecting their eligibility to participate in collegiate athletics. Scholarships 4 Us® will implement *and* have jurisdiction over The Rule of Amateurism<sup>™</sup> according to the Eligibility Criterion found in Section 10 of The Scholarships 4 Us® Program.


Each State's High School League Association may have set regulations that prohibit the participation in non-related events during in-school seasons. For example, participating in an AAU basketball event during high school basketball season may be prohibited in certain states.

The off-season for Scholarships 4 Us<sup>®</sup> will be considered the months in which a high school activity is in-season. It is essential that Accredited Hosts learn their local and/or State High School League Associations' regulations.
